- It is the owner's responsibility to continue training at home outside of class. This is the only path to success.

Liability Release: Owner agrees that Wags & Wiggles Dog Daycare, LLC & Wags & Wiggles Dog Daycare, Part Deux, LLC and its trainers and officers will not be liable for any damage or loss resulting from the failure of the dog to respond to any commands taught to the dog by LAZ or resulting from counseling or advice supplied to owners of dog. Dog's behavior now and in the future is solely the responsibility of the owners of the dog. Should any behavior on the dog's part now or in the future result in damage to the property, owners, or person of some third party, owner agrees to assume full liability to such third party for any and all such damage, and to absolve LAZ and WWDD from any and all obligations to pay such damage to the third party.

I understand that attendance in a dog obedience or agility class is not without risk to myself, members of the family or guests who may observe training, because dogs may sometimes be difficult to control and may be the cause of injury even when handled with the greatest amount of care.
